2. Ratification of 2019-20 OEA Collective Bargaining Agreement: Ms. Flanagan moved and Mr. LeBrun seconded the motion to approve the 2019-20 OEA Collective Bargaining Agreement as presented by Ms. Jonen. In a roll call vote, the following members voted yes: Ms. Flanagan, Mr. LeBrun, Ms. Feeney, Ms. Odorico, Ms. Bizjak and Mr. Zach. Motion passed 6-0.
