Dr. Leslie Bergstrom presented a timeline of the Oregon School District plan and response beginning in March 2020.

- Mid-March: Moved to virtual instruction
- May: Development of steering teams for fall planning
- July 30: Announcement of the Fall Plans for Oregon Phased Restart and Oregon Online
- August 21: Emergency Order #9
- September 10: Supreme Court Injunction
- Fall 2020: Oregon Online and Oregon Phased Restart Reopening Plan (please see November 30 powerpoint)
