- Question for breakout session: "Given your area of expertise, what is important for us to consider before implementing each phase of the plan?

#### **Group One Summary:**

- Balancing physical and mental health impacts: Key in on screening of students who are struggling or encountering new struggles such as learning gaps, dealing with loss of family, loss of jobs, exposure to violence, and/or AODA as they return to school.
- **Data set:** Dial down further to develop a data set specific to our students and their families. The data can evaluate not only our daily changes but trends within our schools. We will need to include effective communication when relaying information to families.
- **School Community Engagement:** Motivating our students and their families to practice safety protocols helps us stay in school.
- **Contact tracing:** There is a good plan in place for contact tracing for Grades K-2. As OSD adds Grades 6-12, do we need to look at staff capacity for contact tracing?
- **Educating the Community:** How can we incorporate this as an educational opportunity to teach our community about what we are learning? Information on safety regarding the vaccine process.

• **Flexibility:** Should we look at being more creative about our school structure (schedule, calendar, grade level restart)?

## **Group Two Summary:**

- **COVID and Kids:** Students, especially younger-aged children, have been shown to not be active spreaders. They need to be taught consistently about how to wear a mask properly, frequent hand washing/sanitizing, and social distancing.
- **Mental Health:** Balancing both mental health and physical health for students with the same level of importance.
- **Equity:** People of color are more likely to suffer from the negative effects and impacts of this pandemic along with families living at or below the poverty level.
- Community Knowledge: Understanding the role the community plays in managing the pandemic and increasing awareness.. Getting the community motivated to follow COVID guidelines, protocols and procedures.
- **School Logistics:** Anything that creates lines (taking temperature and checking for masking before entering a room) creates an opportunity for spread.
- **Kids at risk:** Make sure we are cognizant of those children with less supervision at home and the impacts of those situations, including injury..,
