MINUTES OF THE REGULAR MEETING OF THE SCHOOL BOARD OF THE OREGON SCHOOL DISTRICT HELD ON DECEMBER 12, 2022

The regular meeting of the School Board of the Oregon School District was called to order by Board President Krista Flanagan at 6:30 PM on December 12, 2022 in the OSD Innovation Center at the Oregon High School in the Village of Oregon, Dane County, Wisconsin. Ms. Flanagan thanked those who generously donated to the Oregon School District. In a roll call vote, the following members voted yes: Ms. Wright, Dr. Lokuta, Ms. Bizjak, Ms. Garrison, Mr. LeBrun and Ms. Flanagan. Motion passed 6-0.

B. INFORMATION ITEMS:

1. Public Comment: None

2. OEA Report: None

3. Student Representative Report: Student Representatives Peyton Schroeder and Nate Modjeski provided an update to the Board on recent events happening at Oregon High School. They reported that the workload for students has continued to increase as we move toward the end of the semester. They also shared that academic teams are moving into competition season. Peyton shared that there is a ski trip coming up this Friday. And Nate shared that the Orchestra and Choir had a combined concert last week that was outstanding.

C. ACTION ITEMS:

- 1. Approval of Mike Huemmer Scholarship: Dr. Lokuta moved and Mr. LeBrun seconded the motion to approve the Mike Huemmer Scholarship as presented by Dr. Bergstrom and sponsored by Jake Soule. Board members had the opportunity to ask questions. In a roll call vote, the following members voted yes: Dr. Lokuta, Mr. LeBrun, Ms. Bizjak, Ms. Garrison, Ms. Wright and Ms. Flanagan. Motion passed 6-0.
- 2. Cancellation of the December 26th, 2022 Board Meeting: Ms. Wright moved and Ms. Garrison seconded the motion to cancel the December 26th, 2022 Board Meeting. In a roll call vote, the following members voted yes: Ms. Wright, Ms. Garrison, Ms. Bizjak, Dr. Lokuta, Mr. LeBrun and Ms. Flanagan. Motion passed 6-0.

D. DISCUSSION ITEMS:

1. Committee Reports

- a. Policy Chairperson Garrison stated that the Policy Committee Meeting prior to the Board Meeting and will be bringing Policy 411.01: Graduation Requirements and Policy 715: Head Lice to the January 9th Board Meeting. She also stated that the next Policy Meeting will be January 9th prior to the Board of Education Meeting.
- b. Vision Steering Ms. Bizjak shared that the Vision Steering Committee met last week and discussed Factors Influencing Future Budgets, including the Student Enrollment and Growth Study, Open Enrollment and how facilities will be impacted.
- c. Wellness Dr. Lokuta shared that the Wellness Committee recently met and discussed many important topics. These topics included: increasing movement opportunities for students, conservation and gardening activities and how to incorporate into the curriculum, supporting and improving staff wellness, the AmeriCorps Farm-to-School program and the opportunities to continue incorporating

health foods into the OSD Food Service Program, and the mutually beneficial partnership between the Oregon School District and the Oregon Area Food Pantry.

E. INFORMATION ITEMS:

- Student Services Update: Mental Health Dr. Shannon Anderson, Director of Student Services, presented
 an update to the Board that introduced the Wisconsin School Mental Health Framework, provided an OSD
 update using the Framework, and shared next steps for the Student Services department. Board members
 had the opportunity to ask clarifying questions.
- 2. Spring Election, 2023 President Flanagan shared that there are 3 seats that will be on the ballot for the School Board Election on April 4th, 2023. The seats include one from Area I Village of Oregon which is currently held by Ms. Ahna Bizjak, one from Area II City of Fitchburg, Town of Blooming Grove and Town of Dunn which is currently held by Ms. Heather Garrison and one from Area III, Town of Rutland, Town of Montrose, Town of Oregon, Town of Brooklyn, Town of Union and Ville of Brooklyn which is currently held by Mr. Tim LeBrun. Ms. Bizjak and Ms. Garrison stated that they would be running for reelection and Mr. LeBrun stated that he will not be seeking re-election.
- 3. Vision and Strategic Planning Dr. Bergstrom shared that this was covered in the Student Services Update.
- 4. Teaching and Learning Update: Dual Language Immersion Program Status Update Mr. Jon Tanner, Director of Learning and Student Achievement, presented a status update to the Board of Education on the possibility of a Dual Language Immersion Program. He shared a historical timeline of the program, the District's current offerings, the process used by the Stakeholder group, the potential future options and the next steps for the planning teams.
- 5. Superintendent's Report: Dr. Bergstrom shared her congratulations to OMS Science Teacher and Soccer Coach, Chris Mitchell, who was named the Wisconsin Soccer Coaches Association Coach of the Year in Division 2. This is the third time that he has received this honor. She shared that the High School recently served as a host site for the Dairyland Games Wheelchair Basketball Tournament, and that members of the OHS girls basketball team volunteered at the event as well. Dr. Bergstrom offered her congratulations to the following students and staff who were a part of a Madison Symphony Orchestra concert at the Overture Center: staff members Michelle Kaebisch and Lisel Deussen, and students Olive Andersen, Lia Wochenske, Lily Fellenz, Riley Jackson, Phoebe Yancey, Noah Kienitz and Peyton Yancey. Dr. Bergstrom shared photos of the recent performance of the Nutcracker that took place in the OHS Performing Arts Center as well as photos of students at Netherwood using Play-Doh during a math lesson, and students from RCI taking part in the RCI Wax Museum. She shared that students in Mr. Derrick's art class designed handmade ornaments to the theme of Wisconsin Waters and the ornaments will be displayed in the Wisconsin State Capitol Rotunda. Dr. Bergstrom shared that the OHS Performing Arts Center has been busy with students from all levels showcasing their learning through performances. And lastly, Dr. Bergstrom shared a video and photo of OMS students learning the "Sign of the Week" from a NKE student. The video is shared via

the Panther Press and during Connections each Friday. Students practice along with the video and then take their learnings to the hallways afterwards.

F. CLOSING:

The Board recessed at 8:14 PM to move into closed session.
